

# CleanBC EV charger rebate program

## Deadline to complete EV charger rebate applications is February 28

Customers who submit final completion documentation on or before February 28, 2021 will be processed and paid, if applications meet the program requirements.

New program applications will not be accepted after February 28, 2021 until new program funding has been made available. We have requested for new funding to maintain the existing offers and program requirements.

### SINGLE-FAMILY HOME APPLICATIONS

Scenario	Action
Customer submits application on or before February 28, 2021.	Application will be processed and paid if it meets the program requirements.
Customer tries to submit application after February 28, 2021.	New program applications will not be accepted after February 28, 2021 until new program funding has been made available.
Customer purchases eligible charger and installs during the period when no funding is available.	Customer can apply for a rebate if new program funding is made available. All the program requirements would need to be met. We have requested for new funding to maintain the current offers and program requirements.



## APARTMENT & WORKPLACE APPLICATIONS (EV CHARGER ONLY)

Scenario	Action
Customer tries to submit any Apartment or Workplace EV Charger application after February 28, 2021.	Applications will not be accepted after February 28, 2021 until new program funding has been made available.
Customers who have received pre-approval and submit final completion documentation on or before February 28, 2021.	Applications will be processed and paid if it meets the program requirements.
Customers who have received pre-approval and do not submit final completion documentation by February 28, 2021.	<p>Customers who did not declare or haven't finished their project by February 28, 2021, can complete their application if new program funding is made available. All the program requirements would need to be met.</p> <p>If customers want to ensure they can receive their rebate it is recommended they wait until a decision about funding is made by the Province.</p>
Customers who applied by February 28, 2021 but have not yet received pre-approval.	<p>If a customer's application meets the program requirements BC Hydro will issue a conditional pre-approval for a rebate, that is subject to the Program receiving new funding.</p> <p>Customers could complete their project after receiving conditional pre-approval and submit final completion documentation if new funding is made available. However, if customers want to ensure they can receive their rebate it is recommended they wait until a decision about funding is made by the Province.</p>
Customer did not apply by February 28, 2021 and their project has not been pre-approved or conditionally pre-approved and they install EV charging stations during the period when no funding is available.	<p>A customer would not be eligible to apply for rebates if new funding becomes available at any time.</p> <p>This customer would not be eligible for rebates.</p>



## EV READY APPLICATIONS: PLAN, INFRASTRUCTURE AND CHARGER

Scenario	Action
Customer tries to submit any EV Ready application after February 28, 2021.	Applications will not be accepted after February 28, 2021 until new program funding has been made available.
EV Ready Plans submitted up to and including February 28, 2021.	Applications will be processed and paid if they meet the program requirements.
Customer applied for EV Ready Plan + EV Ready Infrastructure, and have received pre-approval for EV Ready Infrastructure, and do not submit final completion documentation by February 28, 2021.	<p>Customers who did not declare or haven't finished their project by February 28, 2021, can complete their application if new program funding is made available. All the program requirements would need to be met.</p> <p>If customers want to ensure they can receive their rebate it is recommended they wait until a decision about funding is made by the Province.</p>
Customer applied for EV Ready Plan + EV Ready Infrastructure + EV Ready Chargers and have received pre-approval for EV Ready Infrastructure + EV Ready Chargers, and do not submit final completion documentation by February 28, 2021.	<p>Customers who did not declare or haven't finished their project by February 28, 2021, can complete their application if new program funding is made available. Customer did not apply by February 28, 2021 and their EV Ready application has not been pre-approved or conditionally pre-approved and they install electrical infrastructure and/or charging stations during the period when no funding is available.	<p>A customer would not be eligible to apply for rebates if new funding becomes available at any time.</p> <p>This customer would not be eligible for rebates.</p>
